

Texas Brand Registration

Texas and Southwestern Cattle Raisers Association (TSCRA) cooperates with the 254 County Court Clerks offices to provide the Texas Brand Registration site.

Texas does not have a statewide brand registry database. Texas counties may have county-level brand archives. This website is a service to the livestock producers of Texas to learn about the brand registration process and laws in this state.

Brands must be registered in the county or counties in which you operate.

Every 10 years, Texas requires that brands be re-registered in the county or counties in which you operate. The current effective date of the Mark and Brand application is August 31, 2011 to August 31, 2021. The next brand re-registration period begins Aug. 31, 2021, and lasts for one year, concluding on Feb. 28, 2022.

Please note: Brands must be registered in person, unless another method to submit the brand registration form has been approved by your county clerk. Recording fees are \$26.00 per brand. Each location is considered a new recording and requires a registration form.


