At its Feb. 18, 2020 meeting, the Lower Colorado Regional Water Planning Group (Region K) approved its Initially Prepared 2021 Region K Water Plan (IPP). Region K also authorized its administrative agent, the Lower Colorado River Authority (LCRA), to submit the IPP on or before March 3, 2020. The IPP was submitted to the Texas Water Development Board on March 3, 2020.

By issuance of this Public Notice, a 30-day pre-public hearing comment period is currently active until the date of the IPP Public Hearing. The public comment period will continue for no less than 60 days after the date of the IPP Public Hearing. Written comments may be submitted anytime from the date of this notice until June 21, 2020, to Region K's administrative agent, LCRA (details provided below).

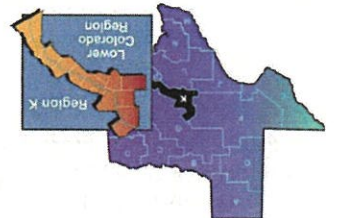
